AN ORDINANCE AMENDING AND SUPPLEMENTING
CHAPTER 205 OF THE CODE OF THE TOWNSHIP OF
SOUTH HACKENSACK ENTITLED "VEHICLES AND
TRAFFIC"

BE IT ENACTED AND ORDAINED, by the Township Committee of the Township of South Hackensack that Chapter 205 Section 30 "Handicap Parking" be amended and supplemented to add the following locations:


Section V: All ordinance or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of said inconsistency.
