Frank Cagas – stated that he would like some of the departments to be trained in chain saw safety since the emergency of downed trees during Hurricane Sandy and he would like a meeting set up for sometime in December to review all storm related issued and to be better prepared for the future.

Public Comments

Lonnie Bedell – 51 Grove Street – he attended the BC Housing Authority meeting and spoke with Domingo regarding the issue of the generator at the Senior Housing on Grove Street. A generator was installed for temporary use by an outside vendor during Hurricane Sandy and that the County should address this problem and have their own onsite generator installed for any emergencies in the future. He also stated that Shari DePalma was recognized for a project in Allendale.
