BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF SOUTH HACKENSACK (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. \$383,000 is available in the Developer's and Escrow Account of the Township of South Hackensack, a municipal corporation of the State of New Jersey (the "Township") in connection with reserve traffic detail services provided by the Township Police Department, to provide for the purchase of various law enforcement equipment for the Township Police Department, including, but not limited to, body cameras, utility/patrol vehicles, firearms, security access equipment, mobile radar units, stationary license plate recognition units, a solar traffic safety sign, police department facility improvements and upgrades, and all work and materials necessary therefor or incidental thereto.

Section 2. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith.

Section 3. This ordinance shall take effect 10 days after the first publication thereof after final adoption.
