Resolution Re: Authorizing the Township of South Hackensack Tax Collector to Prepare and Mail Estimated Tax Bills in Accordance with P.L. 1994, C. 72

WHEREAS, the Township of South Hackensack’s 2022 Municipal Budget has not been adopted, and the County of Bergen has not adopted their 2022 budget and as a result the County will be unable to certify the Township’s final 2022 tax rate; and

WHEREAS, the Tax Collector will be unable to mail the Township’s 2022 third quarter tax bills by the statutory due date; and

WHEREAS, the South Hackensack Tax Collector and Chief Financial Officer have computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and have signed a certification summarizing the tax levies for the previous year, the tax rates and the estimated tax levies for the 2022 calendar year;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of South Hackensack, in the County of Bergen and State of New Jersey on this 20th day of June 2022 as follows:

1. The Township of South Hackensack Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Township for the third installment of 2022 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by L. 1994, c.72 (N.J.S.A. 54:4-66.2 and 54.4-66.3).
2. The estimated calendar year tax levy for 2022 is hereby calculated at \$19,275,970. The maximum amount that the Township will utilize in the preparation of the 2022 estimated tax bills is less than 105% of the 2021 calendar year tax levy.

3. In accordance with New Jersey Statutes, the third installment of 2022 taxes shall not be subject to interest until the later of August 10th or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
